At the time of receipt of this document, access to the system will be enabled accordingly, and each user is responsible for the incorporation of their data into the systems. For this purpose, you or the representative can follow the instructions, according to the tutorial that can be found on the website www.expoturismoruralcr.com. It is the responsibility of the signatory to include correct and reliable information of their client in the system before May 5, 2023; however, we ask you to carry out the corresponding registration in



order to attach the information required by the administration and the coordinating body of the Expo TR and TRC.

1. Expressly manifest:

2. The buyer

- a. The buyer agrees to participate virtually, between May 15 and June 30, 2023.
 - Each appointment will be a maximum of half an hour.
 - The buyer and the seller (exhibitors of tourism products) may accept or reject an appointment, according to parameters of niches or interests of both parties or of each one.
 - The language will always be respectful, between the buyer and the seller.
 - The official language will be English; however, at the request of the buyer, this could vary by common agreement between the parties.



- The buyer agrees to have a minimum of one hundred meetings during the aforementioned period.
- The time of the appointments will be from the Latin American time zone.
- At the end of each of the meetings it is necessary for the parties to report the result of each meeting.

b. According to the register filled out by each of the buyers, up to sixty of them will be selected, so that:

- Sixty buyers will be selected to visit Costa Rica for twelve days.
- The selection will be in accordance with the parameters of the commission established for this purpose.
- The date on which buyers will be notified will be February 1, 2023.
- Those selected will be able to count on the following services free of charge: airport - hotel - airport transfers, transfers to the tours according to the buyer's choice, full meals (does not include alcoholic beverages), visit to the booths at the Expo in person on the days June 16, 17 and 18, 2023 accompanied by an assigned hostess, participation in the opening and closing ceremony of the activity, souvenir, professional risk policy, among others.
- The organizing committee develops a series of complementary activities, for which the buyers must be present. Unjustified absences will not be accepted for any reason, except by force majeure and by consent of the organizing committee. Absence from a scheduled activity will be grounds for expulsion from all scheduled activities, and thus payment for the services consumed up to that time. In such case, the company representing the buyer will be notified in writing. without the decision being appealed by the buyer or the company that represents it.
